# **Product description**

The Monkey sICAM-1 Instant ELISA Kit is an enzyme-linked immunosorbent assay for the quantitative detection of soluble Intercellular Adhesion Molecule-1 levels in cell culture supernatants, monkey serum, plasma, or other body fluids.

## Summary

Intercellular Adhesion Molecule-1 (ICAM-1) is a member of the immunoglobulin supergene family and functions as a ligand for the Lymphocyte Function-Associated Antigen-1 (LFA-1), an  $\alpha$ - $\beta$ -complex that is a member of the leukocyte integrin family of cell-cell and cell-matrix receptors. This family consists of the leukocyte adhesion glycoproteins LFA-1 which mediates lymphocyte adhesion, Mac-1 which mediates granulocyte adhesion and p150,95.

ICAM-1 is a single-chain glycoprotein with a polypeptide core that can be expressed on non-hematopoietic cells of many lineages such as vascular endothelial cells, thymic epithelial cells, other epithelial cells and fibroblasts and on hematopoietic cells such as tissue macrophages, mitogen-stimulated T-lymphoblasts, germinal center B-cells and dendritic cells in tonsils, lymph nodes and Peyer's patches. ICAM-1 is inducible on fibroblasts and endothelial cells by inflammatory mediators such as IL-1, TNF and IFN- $\gamma$  within few hours and is correlated to the infiltration of lymphocytes into inflammatory lesions. ICAM-1 seems to be the initial marker of inflammatory reactions and is expressed prior to, and to a greater extent than is HLA-DR.

# Principles of the test

An anti-monkey sICAM-1 monoclonal coating antibody is adsorbed onto microwells. Monkey sICAM-1 present in the sample or standard binds to antibodies adsorbed to the microwells; an HRP-conjugated monoclonal anti-monkey sICAM-1 antibody binds to monkey sICAM-1 captured by the first antibody.




Fig. 1 First incubation

Following incubation unbound enzyme conjugated anti-monkey sICAM-1 is removed during a wash step and substrate solution reactive with HRP is added to the wells.





Fig. 2 Second incubation

A colored product is formed in proportion to the amount of soluble monkey sICAM-1 present in the sample. The reaction is terminated by addition of acid and absorbance is measured at 450 nm. A standard curve is prepared from seven monkey sICAM-1 standard dilutions and monkey sICAM-1 sample concentration determined.

## **Reagents provided**

1 aluminum pouch with a Microwell Plate (12 strips of 8 wells each) coated with Monoclonal Antibody (murine) to monkey sICAM-1 and HRP-Conjugate (anti-monkey sICAM-1 monoclonal (murine) antibody, Sample Diluent lyophilized

2 aluminum pouches with a monkey sICAM-1 Standard curve (colored)

1 bottle (25 mL) Wash Buffer Concentrate 20x (phosphate-buffered saline with 1% Tween  $^{\rm \scriptscriptstyle M}$  20)

1 vial (15 mL) Substrate Solution (tetramethyl-benzidine)

1 vial (12 mL) Sample Diluent (Use when an external predilution of the samples is needed)

1 vial (15 mL) Stop Solution (1M Phosphoric acid)

2 adhesive Plate Covers

# Storage instructions

Store ELISA plate and Standard curves or whole kit at -20°C. The plate and the standard curves can also be removed, stored at -20°C, remaining kit reagents can be stored between 2°C and 8°C. Expiry of the kit and reagents is stated on labels.

The expiry of the kit components can only be guaranteed if the components are stored properly, and if, in case of repeated use of one component, the reagent is not contaminated by the first handling.



# Sample collection

Cell culture supernatants, monkey serum and plasma were tested with this assay. Other biological samples might be suitable for use in the assay. Remove the serum or plasma from the clot or red cells as soon as possible after clotting and separation.

Samples containing a visible precipitate must be clarified prior to use in the assay. Do not use grossly hemolyzed or lipemic specimens.

Pay attention to a possible *Hook Effect* due to high sample concentrations.

Samples must be stored frozen at -20°C to avoid loss of bioactive monkey sICAM-1. If samples are to be run within 24 hours, they may be stored at  $2^{\circ}$ C to  $8^{\circ}$ C.

Avoid repeated freeze-thaw cycles. Prior to assay, frozen serum or plasma should be brought to room temperature slowly and mixed gently.

Cell culture media without serum component are not suitable for monkey sICAM-1 determination with the ELISA.

# Materials required but not provided

- 5 mL and 10 mL graduated pipettes
- 5  $\mu L$  to 1000  $\mu L$  adjustable single channel micropipettes with disposable tips
- 50  $\mu L$  to 300  $\mu L$  adjustable multichannel micropipette with disposable tips
- Multichannel micropipette reservoir
- Beakers, flasks, cylinders necessary for preparation of reagents
- Device for delivery of wash solution (multichannel wash bottle or automatic wash system)
- Microwell strip reader capable of reading at 450 nm (620 nm as optional reference wave length)
- Glass-distilled or deionized water
- Statistical calculator with program to perform linear regression analysis

- In order to avoid microbial contamination or cross-contamination of reagents or specimens which may invalidate the test use disposable pipette tips and/or pipettes.
- Use clean, dedicated reagent trays for dispensing substrate reagent.

- Glass-distilled water or deionized water must be used for reagent preparation.
- Substrate solution must be at room temperature prior to use.
- Decontaminate and dispose samples and all potentially contaminated materials as if they could contain infectious agents. The preferred method of decontamination is autoclaving for a minimum of 1 hour at 121.5°C.
- Liquid wastes not containing acid and neutralized waste may be mixed with sodium hypochlorite in volumes such that the final mixture contains 1.0% sodium hypochlorite. Allow 30 minutes for effective decontamination. Liquid waste containing acid must be neutralized prior to the addition of sodium hypochlorite.

# Preparation of reagents and samples

- 1. Buffer concentrate should be brought to room temperature and diluted before starting the test procedure.
- 2. If crystals have formed in the buffer concentrate, warm it gently until crystals have completely dissolved.

## Wash buffer (1x)

- 1. Pour entire contents (25 mL) of the Wash Buffer Concentrate (20x) into a clean 500 mL graduated cylinder. Bring to final volume to 500 mL with glass-distilled or deionized water. Mix gently to avoid foaming.
- 2. Transfer to a clean wash bottle and store at 2°C to 25°C. Please note that Wash Buffer (1x) is stable for 30 days.

# Test protocol

#### Note:

- Use plate immediately after removal from -20°C!
- Do not wait until pellets have completely dissolved before applying samples the binding reaction in the standard strips starts immediately after addition of water!
- Do not try to dissolve pellets by pipetting up and down in the wells
  some parts of the pellet could stick to the tip creating high variation of results
- Perform the washing step with at least 400  $\mu L$  of washing buffer as stated in the manual or fill the wells completely otherwise any pellet residues sticking to the rim of the well will not be removed and create high variation of results
- Allow the washing buffer to sit in the wells for a few seconds before aspiration
- Remove covers of the standard strips carefully in order that all the lyophilised pellets remain in the wells

1. Determine the number of microwell Strips required to test the desired number of samples plus microwell Strips for blanks and standards (colored). Each sample, standard, blank, and optional control sample should be assayed in duplicate. Remove extra microwell Strips from holder and store in foil bag with the desiccant provided at -20°C sealed tightly. Place microwell strips containing the standard curve in position A1/A2 to H1/H2 (see Table 1).

- 2. Add distilled water to all standard and blank wells as indicated on the label of the standard strips (A1/A2 to H1/H2).
- 3. Add  $125 \,\mu$ L of distilled water to the sample wells.
- 4. Add 25  $\mu L$  of each Sample, in duplicate, to the designated wells and mix the contents.
- 5. Cover with a Plate Cover and incubate at room temperature (18°C to 25°C) for 2 hours on a microplate shaker.
- 6. Remove Plate Cover and empty wells. Wash the microwell strips 3 times with approximately 400  $\mu$ L Wash Buffer per well with thorough aspiration of microwell contents between washes. Take care not to scratch the surface of the microwells.

After the last wash, tap microwell strips on absorbent pad or paper towel to remove excess Wash Buffer. Use the microwell strips immediately after washing or place upside down on a wet absorbent paper for no longer than 15 minutes. Do not allow wells to dry.

- 7. Pipette  $100 \ \mu$ L of TMB Substrate Solution to all wells, including the blank wells.
- Incubate the microwell strips at room temperature (18°C to 25°C) for about 10 minutes. Avoid direct exposure to intense light.

The color development on the plate should be monitored and the substrate reaction stopped before positive wells are no longer properly recordable. Determination of the ideal time period for color development has to be done individually for each assay.

It is recommended to add the stop solution when the highest standard has developed a dark blue color. The color development can be monitored by the ELISA reader at 620 nm. The substrate reaction should be stopped as soon as Standard 1 has reached an OD of 0.9 - 0.95.

- 9. Stop the enzyme reaction by quickly pipetting 100 µL of Stop Solution into each well, including the blank wells. It is important that the Stop Solution is spread quickly and uniformly throughout the microwells to completely inactivate the enzyme. Results must be read immediately after the Stop Solution is added or within one hour if the microwell strips are stored at 2°C to 8°C in the dark.
- **10.** Read absorbance of each microwell on a spectro-photometer using 450 nm as the primary wave length (optionally 620 nm as the reference wave length; 610 nm to 650 nm is acceptable). Blank the plate reader according to the manufacturer's instructions by using the blank wells. Determine the absorbance of both the samples and the monkey sICAM-1 standards.

**Note:** In case of incubation without shaking the obtained O.D. values may be lower than indicated below. Nevertheless the results are still valid.

## **Calculation of results**

- Calculate the average absorbance values for each set of duplicate standards and samples. Duplicates should be within 20% of the mean.
- Create a standard curve by plotting the mean absorbance for each standard concentration on the ordinate against the monkey sICAM-1 concentration on the abscissa. Draw a best fit curve through the points of the graph.
- To determine the concentration of circulating monkey sICAM-1 for each sample, first find the mean absorbance value on the ordinate and extend a horizontal line to the standard curve. At the point of intersection, extend a vertical line to the abscissa and read the corresponding monkey sICAM-1 concentration.
- Samples have been diluted 1:4, thus the concentration read from the standard curve must be multiplied by the dilution factor (x 4).


**Note:** There is a common dilution factor for samples due to the conjugate which must then be included in the calculation. The samples contribute 100  $\mu$ L to the final volume per well. These 100  $\mu$ L are composed of 75  $\mu$ L of sample diluent plus 25  $\mu$ L of the sample. This is a 1:4 dilution.

The remaining 50  $\mu$ L to give 150  $\mu$ L are due to the addition of 50  $\mu$ L conjugate to all wells.

75  $\mu$ L sample diluent and 50  $\mu$ L conjugate results in 125  $\mu$ L reconstitution volume, addition of 25  $\mu$ L sample (75  $\mu$ L + 25  $\mu$ L = 1:4 dilution)

- Calculation of samples with a concentration exceeding standard 1 may result in incorrect, low monkey sICAM-1 levels (possible Hook Effect). Such samples require further external predilution according to expected monkey sICAM-1 values with Sample Diluent in order to precisely quantitate the actual monkey sICAM-1 level.
- It is suggested that each testing facility establishes a control sample of known monkey sICAM-1 concentration and runs this additional control with each assay. If the values obtained are not within the expected range of the control, the assay results may be invalid.

• A representative standard curve is shown in Figure 4. This curve cannot be used to derive test results. Every laboratory must prepare a standard curve for each group of microwell strips assayed.

Do not use this standard curve to derive test results. A standard curve must be run for each group of microwell strips assayed.

The OD values of the standard curve may vary according to the conditions of assay performance (e.g. operator, pipetting technique, washing technique or temperature effects). Furthermore shelf life of the kit may affect enzymatic activity and thus color intensity. Values measured are still valid.

## Limitations

- Since exact conditions may vary from assay to assay, a standard curve must be established for every run.
- Bacterial or fungal contamination of either screen samples or reagents or cross-contamination between reagents may cause erroneous results.

- Disposable pipette tips, flasks or glassware are preferred, reusable glassware must be washed and thoroughly rinsed of all detergents before use.
- Improper or insufficient washing at any stage of the procedure will result in either false positive or false negative results. Empty wells completely before dispensing fresh wash solution, fill with Wash Buffer as indicated for each wash cycle and do not allow wells to sit uncovered or dry for extended periods.
- The use of mouse IgG antibodies or mouse IgG antibody coupled molecules in the course of animal experiments has significantly increased the number of animals with anti-mouse IgG antibodies (equivalent to human anti-mouse IgG antibodies HAMA). These anti-mouse IgG antibodies may interfere with assays utilizing murine monoclonal antibodies leading to both false positive and false negative results. Serum samples containing antibodies to murine immunoglobulins can still be analyzed in such assays when murine immunoglobulins (serum, ascitic fluid, or monoclonal antibodies of irrelevant specificity) are added to the Sample.

## **Performance characteristics**

#### Sensitivity

The limit of detection of monkey sICAM-1 defined as the analyte concentration resulting in an absorbance significantly higher than that of the dilution medium (mean plus 2 standard deviations) was determined to be 1.05 U/mL (mean of 10 independent assays).

#### Reproducibility

#### Intra-assay

Reproducibility within the assay was evaluated in 3 independent experiments. Each assay was carried out with 6 replicates of 8 samples containing different concentrations of monkey sICAM-1. Two standard curves were run on each plate. The calculated overall intraassay coefficient of variation was <10%.

#### Inter-assay

Assay to assay reproducibility within one laboratory was evaluated in 3 independent experiments by 3 technicians. Each assay was carried out with 6 replicates of 8 samples containing different concentrations of monkey sICAM-1. Two standard curves were run on each plate. The calculated overall inter-assay coefficient of variation was <15%.

#### Spike recovery

The spike recovery was evaluated by spiking 4 levels of monkey sICAM-1 into samples (serum matrix). Recoveries were determined in 3 independent experiments with 6 replicates each. The unspiked sample was used as blank in these experiments. The overall mean recovery was 75%.

#### **Dilution parallelism**

4 samples with different levels of monkey sICAM-1 were analyzed at serial 2-fold dilutions with 4 replicates each. The overall mean recovery was 90%.

## Sample stability

#### Freeze-Thaw stability

Aliquots of samples (unspiked or spiked) were stored at -20°C and thawed 5 times, and the monkey sICAM-1 levels determined. There was no significant loss of monkey sICAM-1 immunoreactivity detected by freezing and thawing.

#### Storage stability

Aliquots of samples (spiked or unspiked) were stored at -20°C, 2°C to 8°C, room temperature, and at 37°C, and the monkey sICAM-1 level determined after 24, 48, and 96 hours. There was no significant loss of monkey sICAM-1 immunoreactivity detected during storage under above conditions.

# **Reagent preparation summary**

### Wash buffer (1x)

Add Wash Buffer Concentrate 20 x (25 mL) to 475 mL distilled water.

## Test protocol summary

- 1. Place standard strips in position A1/A2 to H1/H2.
- **2.** Add distilled water, in duplicate, to all standard and blank wells as indicated on the label of the standard strips.
- 3. Add 125  $\mu$ L distilled water to sample wells.
- 4. Add 25 µL Sample to designated wells.
- 5. Cover microwell strips and incubate 2 hours at room temperature (18°C to 25°C) on a microplate shaker.
- 6. Empty and wash microwell strips 3 times with 400  $\mu L$  Wash Buffer.
- 7. Add 100  $\mu L$  of TMB Substrate Solution to all wells including blank wells.
- **8**. Incubate the microwell strips for about 10 minutes at room temperature (18°C to 25°C).
- 9. Add 100 µL Stop Solution to all wells including blank wells.
- 10. Blank microwell reader and measure color intensity at 450 nm.

**Note:** Samples have been diluted 1:4, thus the concentration read from the standard curve must be multiplied by the dilution factor (x 4).
