Product description

The Rat IFN γ ELISA Kit is an enzyme-linked immunosorbent assay for the quantitative detection of rat IFN γ .

Summary

IFN γ , also called Type III interferon, is a homodimeric glycoprotein containing approximately 21 to 24 kD subunits.

In contrast to IFN α and IFN β synthesis, which can occur in any cell, production of IFN γ is a function of T-cells and NK cells. All IFN γ inducers activate T-cells either in a polyclonal (mitogens or antibodies) or in a clonally restricted, antigen-specific, manner.

IFN γ is produced during infection by T-cells of the

cytotoxic/suppressor phenotype (CD8) and by a subtype of helper Tcells, the Th1 cells. Th1 cells secrete IL-2, IL-3, TNF β and IFN γ , whereas Th2 cells mainly produce IL-3, IL-4, IL-5 and IL-10, but little or no IFN γ . IFN γ preferentially inhibits the proliferation of Th2 but not Th1 cells, indicating that the presence of IFN γ during an immune response will result in the preferential proliferation of Th1 cells.

Type II IFN or IFN γ is a lymphokine that displays no molecular homology with type I IFN, but shares some important biologic activities. Specifically, IFN γ induces an anti-viral state and is antiproliferative. In addition, IFN γ has several properties related to immunoregulation.

- IFN γ is a potent activator of mononuclear phagocytes, e.g. IFN γ stimulates the expression of Mac-1, augments endocytosis and phagocytosis by monocytes, and activates macrophages to kill tumor cells by releasing reactive oxygen intermediates and TNF α.
- IFN γ induces or augments the expression of MHC antigens on macrophages, T- and B-cells and some tumor cell lines.
- On T- and B-cells IFN γ promotes differentiation. It enhances proliferation of activated B-cells and can act synergistically with IL-2 to increase immunoglobulin light-chain synthesis. IFN γ is one of the natural B-cell differentiation factors.
- Finally, IFN γ activates neutrophils, NK cells and vascular endothelial cells.

The role of IFN γ as a disease marker has been demonstrated for a number of different pathological situations.

Principles of the test

An anti-rat IFN γ coating antibody is adsorbed onto microwells.





Fig. 1 Coated microwell

Rat IFN γ present in the sample or standard binds to antibodies adsorbed to the microwells. A biotin-conjugated anti-rat IFN γ antibody is added and binds to rat IFN γ captured by the first antibody.





Following incubation unbound biotin-conjugated anti-rat IFN γ antibody is removed during a wash step. Streptavidin-HRP is added and binds to the biotin-conjugated anti-rat IFN γ antibody.





Fig. 3 Second incubation

Following incubation unbound Streptavidin-HRP is removed during a wash step, and substrate solution reactive with HRP is added to the wells.



A colored product is formed in proportion to the amount of rat IFN γ present in the sample or standard. The reaction is terminated by addition of acid and absorbance is measured at 450 nm. A standard curve is prepared from 7 rat IFN γ standard dilutions and rat IFN γ sample concentration determined.

Storage instructions – ELISA kit

Store kit reagents between 2°C and 8°C. Immediately after use remaining reagents should be returned to cold storage (2°C to 8°C). Expiry of the kit and reagents is stated on labels.

Expiry of the kit components can only be guaranteed if the components are stored properly, and if, in case of repeated use of one component, this reagent is not contaminated by the first handling.

Sample collection and storage instructions

Cell culture supernatant and serum were tested with this assay. Other biological samples might be suitable for use in the assay. Remove serum from the clot as soon as possible after clotting.

Pay attention to a possible *Hook Effect* due to high sample concentrations (see "Calculation of results" on page 4).

Samples containing a visible precipitate must be clarified prior to use in the assay. Do not use grossly hemolyzed or lipemic specimens.

Samples should be aliquoted and must be stored frozen at -20°C to avoid loss of bioactive rat IFN γ . If samples are to be run within 24 hours, they may be stored at 2°C to 8°C (refer to "Sample stability" on page 5).

Avoid repeated freeze-thaw cycles. Prior to assay, the frozen sample should be brought to room temperature slowly and mixed gently.

Materials required but not provided

- 5 mL and 10 mL graduated pipettes
- 5 μL to 1000 μL adjustable single channel micropipettes with disposable tips
- 50 μ L to 300 μ L adjustable multichannel micropipette with disposable tips
- Multichannel micropipette reservoir
- Beakers, flasks, cylinders necessary for preparation of reagents
- Device for delivery of wash solution (multichannel wash bottle or automatic wash system)
- Microwell strip reader capable of reading at 450 nm (620 nm as optional reference wave length)
- Glass-distilled or deionized water
- Statistical calculator with program to perform regression analysis

Precautions for use

- Reagents are intended for research use only and are not for use in diagnostic or therapeutic procedures.
- Do not mix or substitute reagents with those from other lots or other sources.
- Do not use kit reagents beyond expiration date on label.
- Do not expose kit reagents to strong light during storage or incubation.
- Do not pipet by mouth.
- Do not eat or smoke in areas where kit reagents or samples are handled.

- Avoid contact of skin or mucous membranes with kit reagents or samples.

- Avoid contact of substrate solution with oxidizing agents and metal.
- Avoid splashing or generation of aerosols.
- To avoid microbial contamination or cross-contamination of reagents or samples that may invalidate the test, use disposable pipette tips and/or pipettes.
- Use clean, dedicated reagent trays for dispensing the conjugate and substrate reagent.
- Exposure to acid inactivates the conjugate.
- Glass-distilled water or deionized water must be used for reagent preparation.
- Substrate solution must be at room temperature prior to use.
- Decontaminate and dispose samples and all potentially contaminated materials as if they could contain infectious agents. The preferred method of decontamination is autoclaving for a minimum of 1 hour at 121.5°C.
- Liquid wastes not containing acid and neutralized waste may be mixed with sodium hypochlorite in volumes such that the final mixture contains 1.0% sodium hypochlorite. Allow 30 minutes for effective decontamination. Liquid waste containing acid must be neutralized prior to the addition of sodium hypochlorite.

Preparation of reagents

- 1. Buffer Concentrates should be brought to room temperature and should be diluted before starting the test procedure.
- 2. If crystals have formed in the Buffer Concentrates, warm them gently until they have completely dissolved.

Wash buffer

- Pour entire contents (50 mL) of the Wash Buffer Concentrate (20x) into a clean 1000 mL graduated cylinder. Bring to final volume of 1000 mL with glass-distilled or deionized water.
- 2. Mix gently to avoid foaming.
- **3.** Transfer to a clean wash bottle and store at 2°C to 25°C. Please note that Wash Buffer (1x) is stable for 30 days.
- **4.** Wash Buffer (1x) may also be prepared as needed according to the following table:

Assay buffer (1x)

- 1. Pour the entire contents (5 mL) of the Assay Buffer Concentrate (20x) into a clean 100 mL graduated cylinder. Bring to final volume of 100 mL with distilled water. Mix gently to avoid foaming.
- **2.** Store at 2°C to 8°C. Please note that the Assay Buffer (1x) is stable for 30 days.
- **3.** Assay Buffer (1x) may also be prepared as needed according to the following table:

Biotin-Conjugate

Note: The Biotin-Conjugate should be used within 30 minutes after dilution.

Make a 1:100 dilution of the concentrated Biotin-Conjugate solution with Assay Buffer (1x) in a clean plastic tube as needed according to the following table:

Streptavidin-HRP

Note: The Streptavidin-HRP should be used within 30 minutes after dilution.

Make a 1:100 dilution of the concentrated Streptavidin-HRP solution with Assay Buffer (1x) in a clean plastic tube as needed according to the following table:

Rat IFN y standard

- 1. Reconstitute rat IFN γ standard by addition of distilled water.
- Reconstitution volume is stated on the label of the standard vial. Swirl or mix gently to insure complete and homogeneous solubilization (concentration of reconstituted standard = 4 ng/mL). Allow the reconstituted standard to sit for 10-30 minutes. Mix well prior to making dilutions.

The standard has to be used immediately after reconstitution and cannot be stored.

External standard dilution

- Label 7 tubes, one for each standard point: S1, S2, S3, S4, S5, S6, S7.
- **2.** Then prepare 1:2 serial dilutions for the standard curve as follows: Pipette 225 μL of Sample Diluent into each tube.
- Pipette 225 μL of reconstituted standard (concentration = 4 ng/mL) into the first tube, labeled S1, and mix (concentration of standard 1 = 2 ng/mL).
- 4. Pipette 225 μ L of this dilution into the second tube, labeled S2, and mix thoroughly before the next transfer.




Fig. 6 Dilute standards - tubes

- **5.** Repeat serial dilutions 5 more times thus creating the points of the standard curve (see Figure 6).

6. Sample Diluent serves as blank.

Test protocol

- Determine the number of microwell strips required to test the desired number of samples plus appropriate number of wells needed for running blanks and standards. Each sample, standard, blank and optional control sample should be assayed in duplicate. Remove extra microwell strips from holder and store in foil bag with the desiccant provided at 2°-8°C sealed tightly.
- 2. Wash the microwell strips twice with approximately 400 μ L Wash Buffer per well with thorough aspiration of microwell contents between washes. Allow the Wash Buffer to sit in the wells for about 10–15 seconds before aspiration. Take care not to scratch the surface of the microwells.

After the last wash step, empty wells and tap microwell strips on absorbent pad or paper towel to remove excess Wash Buffer. Use the microwell strips immediately after washing. Alternatively microwell strips can be placed upside down on a wet absorbent paper for not longer than 15 minutes. Do not allow wells to dry.




Fig. 7 Dilute standards - microwell plate

3. Standard dilution on the microwell plate (Alternatively the standard dilution can be prepared in tubes - see "External standard dilution" on page 3): Add 100 μ L of Sample Diluent in duplicate to all standard wells. Pipette 100 μ L of prepared standard (see "Rat IFN γ standard" on page 3, concentration = 4000.0 pg/mL) in duplicate into well A1 and A2 (see Table 1). Mix the contents of wells A1 and A2 by repeated aspiration and ejection (concentration of standard 1, S1 = 2000.0 pg/mL), and transfer 100 μ L to wells B1 and B2, respectively (see Figure 7). Take care not to scratch the inner surface of the microwells. Continue this procedure 5 times, creating two rows of rat IFN γ standard dilutions ranging from 2000.0 to 31.3 pg/mL. Discard 100 μ L of the contents from the last microwells (G1, G2) used.

Transfer 100 µL

In case of an external standard dilution (see "External standard dilution" on page 3), pipette 100 μ L of these standard dilutions (S1 - S7) in the standard wells according to Table 1.

- 4. Add 100 μ L of Sample Diluent in duplicate to the blank wells.
- 5. Add 50 μ L of Sample Diluent to the sample wells.
- 6. Add 50 μ L of each sample in duplicate to the sample wells.
- 7. Prepare Biotin-Conjugate (see "Biotin-Conjugate" on page 3).

- 8. Add 50 µL of Biotin-Conjugate to all wells.
- Cover with an adhesive film and incubate at room temperature (18°C to 25°C) for 2 hours on a microplate shaker.
- **10.** Prepare Streptavidin-HRP (refer to "Streptavidin-HRP" on page 3).
- Remove adhesive film and empty wells. Wash microwell strips 3 times according to step 2 of the test protocol. Proceed immediately to the next step.
- 12. Add 100 μL of diluted Streptavidin-HRP to all wells, including the blank wells.
- **13.** Cover with an adhesive film and incubate at room temperature (18°C to 25°C) for 1 hour on a microplate shaker.
- Remove adhesive film and empty wells. Wash microwell strips 3 times according to step 2 of the test protocol. Proceed immediately to the next step.
- 15. Pipette 100 μ L of TMB Substrate Solution to all wells.
- 16. Incubate the microwell strips at room temperature (18° to 25°C) for about 10 minutes. Avoid direct exposure to intense light.

The color development on the plate should be monitored and the substrate reaction stopped (see next point of this protocol) before positive wells are no longer properly recordable. Determination of the ideal time period for color development has to be done individually for each assay.

It is recommended to add the stop solution when the highest standard has developed a dark blue color. Alternatively the color development can be monitored by the ELISA reader at 620 nm. The substrate reaction should be stopped as soon as Standard 1 has reached an OD of 0.9 - 0.95.

- 17. Stop the enzyme reaction by quickly pipetting 100 μL of Stop Solution into each well. It is important that the Stop Solution is spread quickly and uniformly throughout the microwells to completely inactivate the enzyme. Results must be read immediately after the Stop Solution is added or within one hour if the microwell strips are stored at 2°C to 8°C in the dark.
- **18.** Read absorbance of each microwell on a spectro-photometer using 450 nm as the primary wave length (optionally 620 nm as the reference wave length; 610 nm to 650 nm is acceptable). Blank the plate reader according to the manufacturer's instructions by using the blank wells. Determine the absorbance of both the samples and the standards.

Note: In case of incubation without shaking the obtained O.D. values may be lower than indicated below. Nevertheless the results are still valid.

Calculation of results

- Calculate the average absorbance values for each set of duplicate standards and samples. Duplicates should be within 20% of the mean value.
- Create a standard curve by plotting the mean absorbance for each standard concentration on the ordinate against the rat IFN γ concentration on the abscissa. Draw a best fit curve through the points of the graph (a 5-parameter curve fit is recommended).
- To determine the concentration of circulating rat IFN γ for each sample, first find the mean absorbance value on the ordinate and extend a horizontal line to the standard curve. At the point of intersection, extend a vertical line to the abscissa and read the corresponding rat IFN γ concentration.
- If instructions in this protocol have been followed, samples have been diluted 1:2 (50 μ L sample + 50 μ L Sample Diluent) and the concentration read from the standard curve must be multiplied by the dilution factor (x 2).
- Calculation of samples with a concentration exceeding standard 1 may result in incorrect, low rat IFN γ levels (Hook Effect). Such samples require further external predilution according to expected rat IFN γ values with Sample Diluent in order to precisely quantitate the actual rat IFN γ level.

- It is suggested that each testing facility establishes a control sample of known rat IFN γ concentration and runs this additional control with each assay. If the values obtained are not within the expected range of the control, the assay results may be invalid.




Fig. 8 Representative standard curve for rat IFN γ ELISA. Rat IFN γ was diluted in serial 2-fold steps in Sample Diluent. Do not use this standard curve to derive test results. A standard curve must be run for each group of microwell strips assayed.

- A representative standard curve is shown in Figure 8. This curve cannot be used to derive test results. Each laboratory must prepare a standard curve for each group of microwell strips assayed.

The OD values of the standard curve may vary according to the conditions of assay performance (e.g. operator, pipetting technique, washing technique or temperature effects). Furthermore shelf life of the kit may affect enzymatic activity and thus color intensity. Values measured are still valid.

Limitations

• Since exact conditions may vary from assay to assay, a standard curve must be established for every run.

- Bacterial or fungal contamination of either screen samples or reagents or cross-contamination between reagents may cause erroneous results.
- Disposable pipette tips, flasks or glassware are preferred, reusable glassware must be washed and thoroughly rinsed of all detergents before use.
- Improper or insufficient washing at any stage of the procedure will result in either false positive or false negative results. Empty wells completely before dispensing fresh wash solution, fill with Wash Buffer as indicated for each wash cycle and do not allow wells to sit uncovered or dry for extended periods.

Performance characteristics

Sensitivity

The limit of detection of rat IFN γ defined as the analyte concentration resulting in an absorbance significantly higher than that of the dilution medium (mean plus 2 standard deviations) was determined to be 9.9 pg/mL (mean of 6 independent assays).

Reproducibility

Intra-assay

Reproducibility within the assay was evaluated in 3 independent experiments. Each assay was carried out with 6 replicates of 6 serum samples containing different concentrations of rat IFN γ . Two standard curves were run on each plate. The calculated overall intraassay coefficient of variation was < 5%.

Inter-assay

Assay to assay reproducibility within one laboratory was evaluated in 3 independent experiments. Each assay was carried out with 6 replicates of 6 serum samples containing different concentrations of rat IFN γ . Two standard curves were run on each plate. The calculated overall inter-assay coefficient of variation was < 10%.

Spike recovery

The spike recovery was evaluated by spiking 4 levels of rat IFN γ into pooled serum samples. Recoveries were determined in 3 independent experiments with 4 replicates each.

The amount of endogenous rat IFN $\boldsymbol{\gamma}$ in unspiked serum was subtracted from the spike values.

The recovery ranged from 75% to 91% with an overall mean recovery of 85%.

Dilution parallelism

4 serum samples with different levels of rat IFN γ were analyzed at serial 2-fold dilutions with 4 replicates each.

The overall mean recovery was 116%.

Sample stability

Freeze-Thaw stability

Aliquots of spiked serum samples were stored at -20°C and thawed 5 times, and the rat IFN γ levels determined. There was no significant loss of rat IFN γ immunoreactivity detected by freezing and thawing.

Storage stability

Aliquots of spiked serum samples were stored at -20° C, 2° C to 8° C, room temperature, and at 37° C, and the rat IFN γ level determined after 24 hours. There was no significant loss of rat IFN γ immunoreactivity detected during storage at -20° C, 2° C to 8° C, and room temperature. A significant loss of rat IFN γ immunoreactivity (50%) was detected during storage at 37° C after 24 hours.

Specificity

The interference of circulating factors of the immune system was evaluated by spiking these proteins at physiologically relevant concentrations into a rat IFN γ positive serum.

There was no crossreactivity detected.

Expected values

There were no detectable rat IFN γ levels found. Elevated rat IFN γ levels depend on the type of immunological disorder.

Test protocol summary

- 1. Determine the number of microwell strips required.
- 2. Wash microwell strips twice with Wash Buffer.
- 3. Standard dilution on the microwell plate: Add 100 μ L Sample Diluent, in duplicate, to all standard wells. Pipette 100 μ L prepared standard into the first wells and create standard dilutions by transferring 100 μ L from well to well. Discard 100 μ L from the last wells.

Alternatively external standard dilution in tubes (see "External standard dilution" on page 3): Pipette 100 μ L of these standard dilutions in the microwell strips.
