These library kits use a plate-based protocol for easy sample handling and tracking, and for compatibility with automation and high-throughput laboratories. When used with the Precision ID GlobalFiler™ NGS STR Panel v2, this kit requires 1 ng of DNA per target amplification reaction. DNA from various sources, including bodily fluid and bone samples, can be used as starting material.

DNA extraction and quantification kits

Genomic DNA extraction kits

We recommend the PrepFiler $Express^{\mathsf{TM}}$ and PrepFiler $Express^{\mathsf{TM}}$ Forensic DNA Extraction Kits for extracting, then purifying DNA from various forensic sample types:

- PrepFiler Express[™] Forensic DNA Extraction Kit (Cat. No. 4441352) is designed for common forensic sample types, including body fluid stains and swabs of body fluids.
- PrepFiler Express BTA[™] Forensic DNA Extraction Kit (Cat. No. 4441351) is
 designed for challenging forensic sample types such as bone, teeth, and adhesivecontaining substrates including cigarette butts, chewing gum, and tape lifts.

The kits are appropriate for use with samples containing potential PCR inhibitors.

Genomic DNA quantification kits

Several commercially available kits are appropriate for quantifying human DNA. We recommend one of the following kits for quantifying DNA from forensic samples:

- Quantifiler[™] Trio DNA Quantification Kit (Cat. No. 4482910)

The Quantifiler[™] Trio DNA Quantification Kit uses multiple-copy target loci for excellent detection sensitivity. The human-specific target loci (Small Autosomal, Large Autosomal, and Y-chromosome targets) each consist of multiple copies dispersed on various autosomal chromosomes (Small Autosomal and Large Autosomal), or multiple copies on the Y-chromosome. The primary quantification targets consist of relatively short amplicons (75 to 80 bases) to improve the detection of degraded DNA samples. In addition, this kit contains Large Autosomal targets with a longer amplicon (>200 bases) to help in determining if a DNA sample is degraded.

The Quantifiler $^{\text{TM}}$ HP DNA Quantification Kit is the same as the Quantifiler $^{\text{TM}}$ Trio DNA Quantification Kit, but without the Y-chromosome targets.

Prepare the STR target amplification reaction

IMPORTANT! Ion AmpliSeq $^{\text{TM}}$ HiFi Mix is viscous. Pipet slowly and mix thoroughly. We recommend PCR setup on ice or a cold block.

1. Add the following components to each well of a 96-well PCR plate.

Note: For multiple reactions, prepare a master mix.

^[1] Less than 1 ng of gDNA can be used, but adjust the number of PCR cycles appropriately in "Amplify the targets".

2. Seal the plate with a MicroAmp[™] Clear Adhesive Film, vortex briefly, then centrifuge the plate to collect droplets.

Proceed to "Amplify the targets".

Amplify the targets

The cycle number for target amplification depends on the amount of input DNA. Cycle numbers can be increased if the quality or quantity of input DNA is uncertain.

IMPORTANT! When amplifying multiple samples in a single PCR plate, ensure that the input DNA across the samples is roughly equivalent, or the PCR cycle number is based on the sample with the *lowest* quantity. This ensures that the selected cycle number for target amplification is optimal for all the samples in the run. Expect higher stutter with higher cycle number.

Cycle number depending on input DNA

Amount of input gDNA	Number of cycles
1 ng (~300 copies)	23 cycles
0.5–1 ng	23 cycles
0.5 ng	24 cycles
0.250 ng	25 cycles
0.125 ng	26 cycles

To amplify target regions, run the following program:

Stage	Step	Temperature	Time
Hold	Activate the enzyme	99°C	2 minutes
Cycle number	Denature	99°C	15 seconds
(see preceding table)	Anneal and extend	60°C	4 minutes
Hold	_	10°C	Hold

STOPPING POINT The target amplification reactions can be held at 10°C overnight on the thermal cycler. For longer periods, store at -20°C for up to one month.

Partially digest amplicons

- 1. Remove the plate seal, then add 2 μ L of FuPa Reagent (brown cap) to each amplified sample. The total volume is ~22 μ L.
- **2.** Seal the plate with a clear adhesive film, vortex thoroughly, then spin down to collect droplets. Alternatively, mix by pipetting at least half the total volume up and down at least 5 times before sealing the plate.
- **3.** Load in the thermal cycler, then setup and run the following thermal cycling conditions:

60°C	20 minutes	
10°C	Hold (for up to 1 hour)	

STOPPING POINT Store the plate at -20°C.

Ligate adapters to the amplicons, then purify

You *must* ligate a different barcode adapter to each library when:

- Sequencing multiple libraries on a single chip
- Sequencing multiple replicates of DNA libraries from the same sample on a single chip

 $\mathsf{IonCode}^\mathsf{TM}$ barcode adapters are provided at the appropriate concentration, and include forward and reverse adapters in a single well. No further handling is necessary.

IMPORTANT! When handling barcode adapters, avoid cross-contamination.

Perform the ligation reaction

IMPORTANT! If there is visible precipitate in the Switch Solution, vortex or pipet up and down at room temperature to resuspend.

1. Carefully remove the plate seal, then add the following components to each well containing digested amplicons in the order listed.

IMPORTANT! Add the DNA Ligase last. Do not combine DNA Ligase and adapters before adding to digested amplicons.

- 2. Seal the plate with a new MicroAmp[™] Adhesive Film, vortex thoroughly, then centrifuge to collect droplets. Alternatively, mix by pipetting at least half the total volume up and down at least 5 times before sealing the plate.
- **3.** Load the plate in the thermal cycler, then run the following thermal cycling conditions:

STOPPING POINT Samples can be held for up to 24 hours at 10°C on the thermal cycler. For longer periods, store at –20°C.

Purify the libraries

IMPORTANT!

- Bring Agencourt[™] AMPure[™] XP Reagent to room temperature, then vortex thoroughly to disperse the beads before use. Pipet the solution slowly.
- Freshly prepare 70% ethanol for the next steps: Combine 230 μ L of ethanol with 100 μ L of Nuclease-free Water per sample.
- Do NOT substitute a Dynabeads[™]-based purification reagent for the Agencourt[™] AMPure[™] XP Reagent.
- 1. Carefully remove the plate seal, then add 45 μL (1.5X sample volume) of Agencourt[™] AMPure[™] XP Reagent to each library.
- 2. Pipet up and down 5 times to mix the bead suspension with the DNA thoroughly, then incubate the mixture for 5 minutes at room temperature. Alternatively, use a plate mixer (such as the Eppendorf™ MixMate™ mixer with the 96 × 0.2-mL PCR tube holder) to mix the bead suspension. Seal the plate, mix for 5 minutes at 2,000 rpm at room temperature, then centrifuge the plate briefly to collect droplets.
- 3. Place the plate in a magnetic rack (such as the DynaMag[™]–96 Side Magnet; Cat. No. 12331D), then incubate for 2 minutes or until solution clears.
- 4. Carefully remove, then discard the supernatant without disturbing the pellet.
- 5. Add 150 μ L of freshly prepared 70% ethanol, then move the plate side-to-side in the two positions of the magnet to wash the beads. Remove, then discard the supernatant without disturbing the pellet.

Note: If your magnet does not have two positions for shifting the beads, remove the plate from the magnet and gently pipet up and down 5 times (with the pipettor set at 100 μ L). Return the plate to the magnet, then incubate for 2 minutes or until the solution clears.

- **6.** Repeat step 5 for a second wash.
- **7.** Ensure that all ethanol droplets are removed from the wells. Keep the plate in the magnet, then air-dry the beads at room temperature for 5 minutes. Do not overdry.

Note: Residual ethanol inhibits PCR amplification. If needed, centrifuge the plate, then remove residual ethanol before air-drying the beads.

Elute the libraries

- 1. Remove the plate containing the library from the magnet, then add 50 μ L of Low TE to the pellet to disperse the beads.
- **2.** Seal the plate with a MicroAmp $^{\text{TM}}$ Clear Adhesive Film, then vortex thoroughly.

3. Incubate for 5 minutes at room temperature, then centrifuge to collect droplets. Alternatively, use a plate mixer (such as the Eppendorf[™] MixMate[™] mixer with the 96 × 0.2-mL PCR tube holder) to mix the bead suspension. Seal the plate, mix for 5 minutes at 2,000 rpm at room temperature, then centrifuge to collect droplets.

IMPORTANT! For maximum recovery, ensure that the suspension incubates for at least 5 minutes at room temperature.

4. Place the plate on the magnet for at least 2 minutes.

STOPPING POINT Samples can be stored with beads at 4° C for up to one month. For long-term storage at -20° C, place the plate in the magnet, then transfer the sample supernatants to a new plate. Do not store libraries at -20° C in the presence of beads.

Quantify the libraries by qPCR

After eluting each Precision ID library, determine concentration by qPCR with the Ion Library Taq $Man^{@}$ Quantitation Kit (Cat. No. 4468802).

Dilute the libraries for quantification

- 1. If samples have been stored at 4°C, vortex the plate, then centrifuge to collect droplets.
- **2.** Place the plate in the magnetic rack for 2 minutes, or until the supernatant clears.
- 3. Prepare 1:100 dilutions by removing 2 μ L of supernatant, then combine with 198 μ L of Nuclease-free Water.
- **4.** After removing the aliquots, store the plate at 4°C.

Quantify the libraries

Use the Ion Library TaqMan $^{\text{®}}$ Quantitation Kit to analyze each sample, standard, and negative control in duplicate 20- μ L reactions.

1. Prepare three 10-fold serial dilutions of the *E. coli* DH10B Control Library (~68 pM; provided in the kit) at the concentrations listed in the following table. Label them as standards, then use these concentrations in the qPCR experiment setup.

Standard	Control Library volume	Nuclease-free Water volume	Concentration
1	5 μL (undiluted)	45 µL	6.8 pM
2	5 μL Std 1	45 µL	0.68 pM
3	5 μL Std 2	45 µL	0.068 pM

2. Prepare sufficient reaction mixture for replicate reactions for each sample, negative control, and control library dilution. Add an extra reaction to compensate for pipetting error. For each reaction, combine 10 μ L of Ion Library qPCR Master Mix and 1 μ L of Ion Library TaqMan® Quantitation Assay, 20X in a tube, then mix thoroughly.

Component	Volume (1 reaction)
Ion Library TaqMan [®] qPCR Mix	10 μL
Ion Library TaqMan [®] Quantitation Assay, 20X	1 μL

- 3. Aliquot 11 µL into each reaction well (two wells per reaction) of a PCR plate.
- 4. Add 9 μ L of the diluted (1:100) sample library, each control library dilution, or negative control to reaction wells, for a total reaction volume per well of 20 μ L.
- **5.** Set up the real-time PCR instrument.
 - a. Enter the concentrations of the control library standards.
 - **b.** Select ROX[™] Reference Dye as the passive reference dye.
 - c. Enter a reaction volume of 20 μ L.
 - **d.** Select FAM^{TM} dye/MGB as the TaqMan[®] probe reporter/quencher.
 - **e**. Enter the following run parameters, depending on your system.

6. Run the reactions, then collect the real-time data.

See "Dilute, pool, and store the libraries" on page 30 for library concentrations required for template preparation. Depending on your quantification results, proceed with one of the following options:

- If sufficient library was prepared, continue to "Dilute, pool, and store the libraries" on page 30.
- If insufficient library was prepared, continue to "(Optional) Amplify and purify the libraries" on page 28.
- Continue with less than optimal library concentration and proceed to "Dilute, pool, and store the libraries" on page 30. See Appendix A, "Troubleshooting" for effects of using low library concentration.

(Optional) Amplify and purify the libraries

A library that yields less than the recommended concentration can be rescued by library amplification. Amplified libraries need to be purified before quantification and

Amplify the libraries

1. Combine 25 μ L of each unamplified library (total undiluted library is ~50 μ L, from "Elute the libraries" on page 25) with 72 μ L of Platinum PCR SuperMix HiFi and 3 μ L of Library Amplification Primer Mix from the Precision ID Library Kit in one well of a 96-well PCR plate.

Note: The Platinum[™] PCR SuperMix HiFi and Library Amplification Primer Mix can be combined before addition.

- 2. Seal the plate with MicroAmp[™] Adhesive Film, vortex thoroughly, then centrifuge briefly to collect droplets. Alternatively, mix by pipetting at least half the total volume up and down at least 5 times before sealing the plate.
- 3. Load the plate in a thermal cycler, then run the following program:

Stage	Temperature	Time
Hold	98°C	2 minutes
5–10 cycles	98°C	15 seconds
	64°C	1 minute
Hold	10°C	Hold (for up to 24 hours)

STOPPING POINT Samples can be held overnight or up to 24 hours at 10°C on the thermal cycler. For longer periods, store at -20°C.

Purify the amplified libraries

Perform a two-round purification process with the Agencourt[™] AMPure[™] XP Reagent:

- First round at 0.5X bead-to-sample-volume ratio: High molecular-weight DNA
 is bound to beads, while amplicons and primers remain in solution. Save the
 supernatant.
- Second round at 1.2X bead-to-original-sample-volume ratio: Amplicons are bound to beads, and primers remain in solution. Save the bead pellet, and elute the amplicons from the beads.

IMPORTANT!

- Bring Agencourt $^{\text{\tiny TM}}$ AMPure $^{\text{\tiny TM}}$ XP Reagent to room temperature and vortex thoroughly to disperse the beads before use. Pipet the solution slowly.
- Use freshly prepared 70% ethanol for the next steps. Combine 230 μL of ethanol with 100 μL of Nuclease-free Water per sample.
- Do NOT substitute a Dynabeads[™]-based purification reagent for the Agencourt[™] AMPure[™] XP Reagent.

First-round purification

- 1. Tap the plate gently on a hard flat surface, or centrifuge briefly to collect the contents at the bottom of the wells, then remove the plate seal.
- 2. Add 50 μL (0.5X sample volume) of Agencourt[™] AMPure [™] XP Reagent to each plate well containing ~100 μL of sample. Mix the bead suspension with the DNA thoroughly by pipetting up and down 5 times.
- 3. Incubate the mixture for 5 minutes at room temperature.
- **4.** Place the plate in a magnet such as the DynaMag[™]–96 Side Magnet for at least 5 minutes, or until the solution is clear.
- **5.** Carefully transfer the supernatant from each well to a new well of the 96-well PCR plate without disturbing the pellet.

IMPORTANT! The **supernatant** contains the desired amplicons. Do not discard!

Second-round purification

- To the supernatant from "First-round purification" on page 29 above, add 120 μL (1.2X original sample volume) of Agencourt[™] AMPure XP Reagent. Mix the bead suspension with the DNA thoroughly by pipetting up and down 5 times.
- 2. Incubate the mixture for 5 minutes at room temperature.
- **3.** Place the plate in the magnet for 3 minutes or until the solution is clear. Carefully remove, then discard the supernatant without disturbing the pellet.

IMPORTANT! The amplicons are bound to the beads. **Save the bead pellet.**

4. Add 150 μ L of freshly prepared 70% ethanol to each well, then move the plate side to side in the magnet to wash the beads. Remove and discard the supernatant without disturbing the pellet.

Note: If your magnet does not have two positions for shifting the beads, remove the plate from the magnet and gently mix by pipetting up and down 5 times (with the pipettor set at 100 μ L), then return the plate to the magnet and incubate for 2 minutes or until the solution clears.

- **5.** Repeat step 4 for a second wash.
- **6.** Ensure that all ethanol droplets are removed from the wells. Keeping the plate in the magnet, air-dry the beads at room temperature for 2–5 minutes. **Do not overdry.**
- 7. Remove the plate from the magnet, then add 50 μL of Low TE to the pellet to disperse the beads.

8. Seal the plate with MicroAmp[™] Adhesive Film, vortex thoroughly, then centrifuge to collect droplets.

Alternatively, use a plate mixer (such as the Eppendorf^{\mathbb{M}} MixMate^{\mathbb{M}} mixer with the 96 × 0.2-mL PCR tube holder) to mix the bead suspension. Seal the plate, mix for 5 minutes at 2,000 rpm at room temperature, then centrifuge to collect droplets.

- **9.** Incubate at room temperature for at least 2 minutes.
- **10.** Place the plate in the magnet for at least 2 minutes, then analyze an aliquot of the supernatant as described in "Quantify the libraries by qPCR" on page 26.

IMPORTANT! The **supernatant** contains the desired amplicons. **Do not discard!**

Dilute, pool, and store the libraries

IMPORTANT! To ensure adequate coverage, we recommend that you pool no more than 32 barcoded libraries to run on a single Ion 530^{T} Chip.

Dilute the libraries

1. After the run is complete, calculate the average concentration of each undiluted library using the following equation:

Avg concentration of undiluted library = (qPCR mean quantity) × (library dilution)

For example:

• qPCR mean quantity: 3 pM

• Sample library dilution: 100

The average concentration of the undiluted library: $(3 \text{ pM}) \times (100) = 300 \text{ pM}$

2. Dilute libraries as described in the following table.

Pool the libraries

IMPORTANT! The quality of sequencing data relies on achieving the correct concentration of starting library.

After diluting each sample library to 50 pM, pool equal volumes, then use the pooled library in a template preparation reaction on the Ion Chef^{$^{\text{TM}}$} Instrument.

Use the following recommendations for the number of manually-prepared sample libraries loaded per chip. The recommendations are based at least 100X coverage. You may need to adjust the number of samples per chip based on your individual coverage requirements, sample quality, and throughput.

Note: Ensure that the volume of the pooled library, or single library, is $\geq 25 \mu L$.



- 4 Position D (Output tube)

2. Pipet 150 μ L of the panel into the Position A tube and 150 μ L into the Position B tube in the Precision ID DL8 Reagents cartridge.

IMPORTANT! 150 μ L of the panel must be added to each tube, or the library preparation will fail.


Note:

- Use the same volumes if you are processing fewer than 8 samples.
- When the run is complete, the tube in Position D contains 700 μL of combined barcoded libraries.

Add the DNA to the Precision ID DL8 IonCode[™] Barcode Adapters

- Remove the plate seal from a Precision ID DL8 IonCode[™] Barcode Adapters Plate (provided), then discard.
- 2. Pipet 15 μ L of each DNA sample (67 pg/ μ L, 1 ng total) into wells A1 to H1 of the plate as shown in the following figure.

IMPORTANT! Carefully inspect each well for air bubbles. Remove any air bubbles by gentle pipette mixing. Alternatively, centrifuge the plate briefly in a plate centrifuge.




- ① Column 1 wells containing 15 μ L of each diluted DNA sample (67 pg/ μ L).
- ② Column 6 wells containing 8 dried-down IonCode™ barcodes. Lowest number is in A6 and highest is in H6. All appear light blue in the actual plates.

Note: If processing fewer than 8 samples, it is preferable to add replicates or positive control samples to the run. Otherwise, pipet 15 μ L of Nuclease-free Water into column 1 wells that do not contain a DNA sample.


Note: If processing 5 or fewer samples, quantify your output combined library by qPCR to ensure that an optimal concentration is used in templating reactions.

Load the Ion Chef[™] Instrument for library preparation

Follow the procedure below to load the Ion $Chef^{^{TM}}$ Instrument. A completely loaded instrument is shown in the following figure:

 - **a.** On the instrument touchscreen, tap **(a)** (**Open Door)**, then wait for the latch to open.
 - **b.** Lift the instrument door to the top of the travel until the latch mechanism engages.

- 2. Load the Precision ID DL8 Solutions cartridge into the Solutions station.
 - **a**. Gently tap the cartridge on the bench to force the reagents to the bottoms of the tubes.
 - **b.** Load the cartridge into the Solutions station so that it snaps into place, and is level on the deck.
- 3. Load the Precision ID DL8 Reagents cartridge into the Reagents station.
 - a. To force the reagents to the bottoms of the tubes, gently tap the cartridge on the bench and verify that all the liquid is at the bottom, and not splashed on the side of the tubes.
 - **b.** Load the cartridge into the Reagents station so that it snaps into place, and is level on the deck.

IMPORTANT! Do not force the cartridge into place. Each cartridge fits only one location on the deck and in one orientation. If a cartridge does not fit, ensure that you are loading the correct cartridge in the correct orientation.

IMPORTANT! Ensure that 4 flagged tubes are uncapped, then loaded in Positions A–D of the Reagents cartridge, and Primer Pools are loaded in Positions A and B.

- **4.** Load a new Ion AmpliSeq[™] Tip Cartridge L8 into the New Pipette Tip station (left side of deck).
 - **a.** Unwrap the Ion AmpliSeq $^{\text{TM}}$ Tip Cartridge L8, then remove the cover to expose the pipette tips.
 - b. Pull the tip station catch backwards to open the locking bracket. Load the Ion AmpliSeq[™] Tip Cartridge L8, then push the locking bracket closed.

IMPORTANT! If you do not close the locking bracket, the run will fail.

- **5.** Load an empty tip cartridge from a previous run into the Used Tip station.
- **6.** Load the Precision ID DL8 IonCode[™] Barcode Adapters 96 Well Plate containing gDNA onto the thermal cycler block and press down to seat it.
- 7. Slide a new Framed PCR Foil Seal underneath the automated heated cover.

IMPORTANT! When the Framed PCR Foil Seal is positioned correctly, its tabs project upward and contact the heated cover.

- **8.** Load the Enrichment Cartridge into the Enrichment station, then press down on the cartridge to ensure that it is level with the instrument deck.
- **9.** Close the instrument door by first lifting it up slightly to disengage the locking mechanism, then pushing down on the door so that the lower locks engage.

IMPORTANT! After closing the door, confirm that both sides of the door are locked down.

Start the Ion Chef[™] run

Perform the following steps to start a Precision ID DL8 Kit run on the Ion $\mathsf{Chef}^{^\mathsf{TM}}$ Instrument.

1. On the Ion Chef[™] home touchscreen, tap **Set up run**.



2. Tap Step by step, then tap AmpliSeq on the Run Options screen.

Note: To bypass the step by step deck loading guide, tap Quick start.





3. Ensure that you have loaded the Ion Chef[™] deck with Precision ID DL8 Kit consumables by advancing through the step by step deck loading steps on the instrument touchscreen.






Note: If the PCR plate is not recognized, select the appropriate plate when prompted. Because no sample set was selected or planned in the Torrent Server, the following warning appears: "No sample Set detected. Do you want to continue?" Tap **OK**.


- **8.** Review panel and amplification entries for the run in the **AmpliSeq Confirmation Window**, then tap **Start Run**.
- **9.** After about 7 hours, return to the Ion Chef[™] Instrument. On the **Run Complete** screen, tap **Next** to go to the unloading and cleaning steps.





IMPORTANT! After a run, the Ion $Chef^{^{TM}}$ Instrument holds the barcoded libraries in the tube that is loaded in Position D of the Reagents cartridge. To avoid fluid loss due to evaporation, remove, then cap the tube of combined barcoded libraries as soon as possible after run completion. Do not leave the tube in the instrument longer than 24 hours after the start of the run. After 24 hours from the start of the run, the instrument chiller will stop actively cooling, and the sample will be held at room temperature.





IMPORTANT! Do not reuse the waste pipette tip rack. Always move the empty Tip Cartridge L8 from the new tip position to the waste tip position.

6. Move the empty Tip Cartridge L8 from the New Pipette Tip station to the Used Pipette Tip station.

IMPORTANT! Do not discard the empty Tip Cartridge L8.

7. Remove, then discard the Enrichment Cartridge.

Quantify the combined library by qPCR

After unloading the Ion $\mathsf{Chef}^{^\mathsf{TM}}$ Instrument, determine the concentration of the combined library pools by qPCR with the Ion Library TaqMan[®] Quantitation Kit (Cat. No. 4468802).

Dilute the combined library for quantification

- 1. If the combined library tube has been stored at 4°C, vortex the tube, then centrifuge briefly to collect droplets.
- 2. Prepare a 1:100 dilution by combining 2 μL with 198 μL of Nuclease-free Water.
- **3.** After removing the aliquot, store the tube at 4°C.

Quantify the combined library by qPCR

Use the Ion Library TaqMan $^{\circ}$ Quantitation Kit to analyze the combined sample library, standard, and negative control in duplicate 20- μ L reactions.

1. Prepare three 10-fold serial dilutions of the *E. coli* DH10B Control Library (~68 pM; provided in the kit) at the concentrations listed in the following table. Label them as standards, then use these concentrations in the qPCR experiment setup.

Standard	Control Library volume	Nuclease-free Water volume	Concentration
1	5 μL (undiluted)	45 µL	6.8 pM
2	5 μL Std 1	45 µL	0.68 pM
3	5 μL Std 2	45 μL	0.068 pM

2. Prepare sufficient reaction mixture for replicate reactions for each sample, negative control, and control library dilution. Add an extra reaction to compensate for pipetting error. For each reaction, combine 10 μL of Ion Library qPCR Master Mix and 1 μL of Ion Library TaqMan Quantitation Assay, 20X in a tube, then mix thoroughly.

Component	Volume (1 reaction)
Ion Library TaqMan® qPCR Mix	10 μL
Ion Library TaqMan [®] Quantitation Assay, 20X	1 μL

- 3. Aliquot 11 μ L into each reaction well (two wells per reaction) of a PCR plate.
- **4.** Add 9 μ L of the diluted (1:100) sample library, control library dilution, or negative control to reaction wells, for a total reaction volume per well of 20 μ L.
- **5.** Set up the real-time PCR instrument.
 - **a.** Enter the concentrations of the control library standards.
 - **b.** Select ROX^{TM} Reference Dye as the passive reference dye.
 - c. Enter a reaction volume of 20 μ L.
 - **d.** Select FAM[™] dye/MGB as the TaqMan[®] probe reporter/quencher.
 - e. Enter the following run parameters, depending on your system.

Dilute the combined libraries

IMPORTANT! Before proceeding, dilute the combined libraries to the optimal input concentration. The quality of sequencing data relies on achieving the correct concentration of starting library.

Dilute the combined libraries as described in the following table. Then use polyclonality and low-quality filter results from a sequencing run performed with ISPs templated at the starting concentration to titrate up or down to achieve optimal concentrations, if needed.

Panel	Dilute to	Minimum volume

Note:

- If the concentration of the undiluted combined library is in the 30–50-pM range, it is acceptable to continue with template preparation. Expect to see lower coverage for libraries present at lower relative concentration.
- If you are pooling combined libraries (details in the next section), the minimum volume of the pool must be 25 $\mu L.$

Pool the combined libraries

After diluting library pools prepared on the Ion $\mathsf{Chef}^{^\mathsf{TM}}$ Instrument to the target concentration (pM), you can "super-pool" combined libraries by combining equal volumes of the library pools, provided the pools were prepared with different Precision ID DL8 $\mathsf{IonCode}^{^\mathsf{TM}}$ Barcode Adapters. Use the combined library pools in template preparation reactions on the Ion $\mathsf{Chef}^{^\mathsf{TM}}$ Instrument.

Use the following recommendations for the number of manually-prepared sample libraries loaded per chip. The recommendations are based at least 100X coverage. You may need to adjust the number of samples per chip based on your individual coverage requirements, sample quality, and throughput.

Note: Ensure that the volume of the pooled library, or single library, is $\geq 25 \mu L$.

Store the libraries

Store both diluted and undiluted libraries at 2° C to 8° C for up to 1 month. For long-term storage, store libraries at -30° C to -10° C.

Clean the Ion Chef[™] Instrument

About the cleaning protocol

The Ion Chef[™] System includes an automated cleaning function that must be performed following every run. The cleaning routine is initiated from the Ion Chef[™] Instrument touchscreen and is designed to minimize potential contamination. During the routine, the instrument irradiates the deck with ultraviolet light for 1 minute after all consumables have been removed from the instrument.

IMPORTANT! Although the Ion $Chef^{^{TM}}$ Instrument cleaning routine provides some protection against contamination, it is not a substitute for good laboratory technique or precautions. When preparing DNA libraries for use or when preparing the Ion $Chef^{^{TM}}$ Instrument, make certain to observe sterile laboratory procedures at all times to ensure minimal contamination.

Clean the Ion Chef[™] Instrument

IMPORTANT! Clean the Ion $Chef^{^{TM}}$ Instrument after every run. To prevent contamination, do not operate the instrument unless it has been recently cleaned.

- 1. Close the instrument door by first lifting it slightly to disengage the locking mechanism, then pushing down on the door until the locks engage.
- On the Ion Chef[™] Instrument touchscreen that appears after run completion, tap Next.



Note: You can also clean the instrument at any time starting from the home touchscreen. Tap **Settings**, then tap **Clean Ion Chef**.



3. Ensure that you have removed all consumables from the Ion Chef[™] Instrument, then tap **Next**.



4. With the door closed, tap **Start**.



The instrument performs a Deck Scan before starting the cleaning routine. The Ion $Chef^{^{TM}}$ Instrument stops ventilation and illuminates the ultraviolet (UV) light in the instrument.



CAUTION! The Ion $\mathsf{Chef}^{^\mathsf{TM}}$ Instrument emits UV light at 254 nm. Wear appropriate eye wear, protective clothing, and gloves when working near the instrument. Do not look directly at the UV light while it is illuminated during the cleaning routine.

Note: If needed, repeat Ion Chef^{TM} library preparation for remaining libraries (up to 32 barcodes).



1. Unpack the Ion S5[™] Precision ID Chef Reagents cartridge 45 minutes before use, then allow it to warm to room temperature.

IMPORTANT! The Reagents cartridge must sit at room temperature for 45 minutes before use.

2. Pipet 25 μL of diluted library pool (see "Dilute the libraries" on page 30 or "Dilute the combined libraries" on page 46) to the bottom of the appropriate Ion Chef[™] Library Sample Tube (flagged tubes in the following figure).



IMPORTANT!

- Rated centrifuge speeds are only intended for operation with the provided buckets and approved consumable chips, tubes, and sample preparation reagents.
- The Chip-loading centrifuge is rated to operate at the listed rotational frequencies with the chip buckets, chips, and adapters. The centrifuge must be load-balanced. Proper care must be taken to load the buckets properly. If excessive vibrations arise, check that items are installed properly and rotors are load-balanced.
- Use only the materials supplied in the Ion S5[™] Precision ID Chef & Sequencing Kit to run the centrifuges at the rated speeds. Do not remove or change the rotors.
 Inspect the buckets before each use to assure normal operation.
- Confirm that the instrument is powered on and has been cleaned following the last

 - d. Ensure that the tabs at all four sorners of the adapter are fitted into the slots in the centrifuge bucket. Loading can fail if the adapter is not attached securely.



Confirm that consumables are correctly installed

Before continuing:

- Confirm that each cartridge is at the correct location and in the correct orientation.
- Press down on all cartridges to confirm that they are firmly pressed into place.
- Confirm that all tubes in the Ion S5[™] Precision ID Chef Reagents cartridge, including the tube of NaOH in Position C, are uncapped and firmly pressed into place.
- Confirm that the centrifuge lids are installed correctly so that the port is oriented toward the rear of the instrument.
- Confirm that the tube and chip buckets are seated securely in the rotor arms of the Chip-loading and Recovery centrifuges, and that the consumables they contain are correctly installed.



CAUTION! To ensure correct and safe instrument operation, you must confirm that all consumables are installed correctly to the deck before you start a run. The Ion $\mathsf{Chef}^{^\mathsf{TM}}$ Instrument does not verify all aspects of the consumable setup prior to beginning each run.

Single chip loading workflow

You can set up an Ion Chef[™] run to load a single chip instead of two, using the Ion Chef[™] S5 Series Chip Balance loaded opposite to the sequencing chip in the Chip-loading centrifuge. The Ion Chef[™] S5 Series Chip Balance is provided in the Ion S5[™] Installation Kit.

Load the Ion $Chef^{TM}$ Instrument as you would normally load the system. For single chip loading, perform the following steps:





By selecting	You can obtain QC samples
Time	immediately after the run ends, at the time you specify (13 hours 8 minutes after run start).
Pause	when the instrument pauses operation before the chip loading step (approximately 11 hours into the run).

Note: If you are unsure when you will sequence the loaded chips, select the Pause option.

9. On the **Run Options** screen, tap **Start run** to start the run.

Note: If you stop the run for any reason, tap **Cancel**, then tap **Yes** to verify the cancellation.


If the Ion Chef^{\mathbb{N}} Instrument encounters a problem during the run, it aborts the run, then displays the error on the instrument touchscreen. If a run fails:

- 1. Remove the consumables from the deck, then clean the instrument. If possible, retain the consumables for troubleshooting.
- 2. Reset, then reattempt the run. If the run fails again, contact Technical Support to troubleshoot the problem.
- 10. Initialize the Ion S5[™], Ion S5[™] XL, or Ion GeneStudio[™] S5 Series Sequencer or at least 40 minutes before the Ion Chef[™] System finishes chip loading. Initialization of the instrument can be performed up to 24 hours before starting a sequencing run. If the intent is to perform two sequencing runs per initialization, the first run must be completed and the second run must be started within the 24-hour period. By initializing the sequencer before completion of chip loading, you ensure that the chips can be sequenced as soon as possible after loading is complete.
- **11.** When the run is complete, unload the Ion Chef[™] Instrument and sequence the chips immediately.

Note: If you cannot sequence a loaded chip immediately, place the chip into a separate chip storage container, then store at 4°C until you are ready to sequence it (up to 6–8 hours maximum).



Clean the Ion Chef[™] System

About the cleaning protocol

The Ion $Chef^{^{TM}}$ System includes an automated cleaning function that must be performed following every run. The cleaning routine is initiated from the Ion $Chef^{^{TM}}$ Instrument touchscreen and is designed to minimize potential contamination. During the routine, the instrument irradiates the deck with ultraviolet light for 1 minute after all consumables have been removed from the instrument.


IMPORTANT! Although the Ion $Chef^{^{TM}}$ Instrument cleaning routine provides some protection against contamination, it is not a substitute for good laboratory technique or precautions. When preparing DNA libraries for use or when preparing the Ion $Chef^{^{TM}}$ Instrument, make certain to observe sterile laboratory procedures at all times to ensure minimal contamination.

- Isopropanol, 70% solution
- Wipes, lint-free

4. With the door closed, tap **Start**. The instrument performs a Deck Scan before starting the cleaning routine. The Ion Chef[™] Instrument stops ventilation, then illuminates the ultraviolet (UV) light in the instrument for ~1 minute.





CAUTION! The Ion Chef^{$^{\text{M}}$} Instrument emits UV light at 254 nm. Wear appropriate eye wear, protective clothing, and gloves when working near the instrument. Do not look directly at the UV light while it is illuminated during the cleaning routine.

Note: The system uses RFID technology to verify that the proper reagents are loaded in positions 3, 5, and 6. Reagents that exceed their expiration date or usage count generate an error message prompting the user to replace the reagent before performing the run.

Note: RFID regulatory information can be found on the main screen under **Options** ▶ **Regulatory info**.

Before you begin

The Ion $S5^{\text{\tiny TM}}/Ion S5^{\text{\tiny TM}}$ XL Sequencer and Ion GeneStudio S5 Series Sequencers are equipped to verify the compatibility of each chip and consumable that is loaded during initialization and sequencing, and that these components do not exceed their expiration date. To avoid exceptions during initialization, inspect this information for each consumable before installing onto the instrument.

- Unbox the Ion S5[™] Precision ID Sequencing Reagents cartridge 45 minutes before use, then allow it to equilibrate to room temperature.
 Do not remove the Ion S5[™] Precision ID Sequencing Reagents cartridge from its packaging until immediately before loading, so that you can return the unused cartridge to storage if your sequencing run is delayed.
- Unbox the Precision ID Wash Solution bottle. Invert the bottle 5 times within its vacuum-sealed bag, then swirl at an angle to mix thoroughly.
- Remove the Precision ID Wash Solution bottle from its vacuum-sealed bag, then remove the red cap from the Precision ID Wash Solution and Precision ID Cleaning Solution bottles immediately before installing on the instrument.

Required sequencer cleanings

HID Ion $S5^{\text{TM}}/Ion S5^{\text{TM}}$ XL Sequencers and HID Ion GeneStudio S5 Series Sequencers require cleaning before initialization. Cleaning is normally performed automatically at the completion of the previous sequencing run. When two sequencing runs are performed on a single initialization, the post-run cleaning is performed after the second sequencing run. However, if the "Enable post-run clean" checkbox is deselected to allow a second run, and a second run is not performed, the instrument will not allow the subsequent initialization to proceed until a manual cleaning has been performed. See "Perform a manual cleaning of the sequencer" on page 102 for more information on how to perform a manual cleaning.

If a sequencer is initialized and a sequencing run is not started within 24 hours, or a run is not started or completed due to a power failure or an abort, do not perform a manual cleaning. An instrument reset run is required before reinitialization. See "Perform an instrument reset run with an initialized, unused Ion $S5^{\text{M}}$ Precision ID Sequencing Reagents cartridge" on page 103 for more information.

Initialize the sequencer


1. In the instrument touchscreen main menu, tap **Initialize**. The door, chip, and Reagent cartridge clamps unlock.



- **2.** When prompted, remove the Precision ID Wash Solution bottle to access the waste reservoir, then remove and empty the waste reservoir.
- **3.** Reinstall the empty waste reservoir.
- **4.** Replace the expended Ion S5[™] Precision ID Sequencing Reagents cartridge with a new cartridge equilibrated to room temperature.

Note: Dispose of used reagents appropriately.

5. Ensure that the new Precision ID Wash Solution bottle has been thoroughly mixed. If not, invert the bottle 5 times, then swirl the bottle at an angle to mix thoroughly. Then remove the red cap and install.



6. Ensure that the used sequencing chip from the previous run is properly seated in the chip clamp and the chip clamp is pushed in all the way.

7. If necessary, install a new Precision ID Cleaning Solution bottle.

Note: The Precision ID Cleaning Solution bottle contains sufficient reagent to complete 4 cleanings.

8. Close the door, then tap Next.

The instrument confirms that the consumables and chip are properly installed and that the Precision ID Cleaning Solution bottle contains enough reagent to perform the post-run clean. Follow all on-screen recommendations to ensure proper installation of required consumables.

IMPORTANT! If the allowed number of post-run cleaning procedures has been met, the instrument will prompt the user to replace the Precision ID Cleaning Solution bottle.

9. When initialization is complete (~30–40 minutes), tap **Home**.

The instrument is now ready for a sequencing run.

Start the sequencing run

We recommend that you sequence loaded chips on the sequencer as soon as possible after chip loading and instrument initialization are complete. However, successful sequencing runs can be started up to 24 hours after instrument initialization.


Note: Do *not* press the power button during a run. Interrupting power to the instrument during a run can result in sequencing run failure and loss of sample.

- 1. After completion of initialization, tap **Run** in the instrument touchscreen. The door and chip clamp unlock.
- **2.** Remove the used sequencing chip, then secure a chip loaded with template-positive Ion Sphere $^{\text{TM}}$ Particles in the chip clamp.
- 3. Push the chip clamp all the way in to engage, close the instrument door, then tap **Next**.
- **4.** Confirm that the correct Planned Run has auto-populated, then tap **Review**.



5. If the run is the first of two sequencing runs after an initialization, deselect the **Enable post-run clean** checkbox, then tap **Review**.

Note: When starting the second sequencing run on a single initialization, ensure that the **Enable post-run clean** checkbox is selected, so that the post-run cleaning is performed automatically.



- **6.** Confirm that the pre-populated settings are correct, or make changes using the buttons and dropdown lists if needed.
- **7.** Confirm that the instrument door is closed, then tap **Start run** to start the sequencing run.

IMPORTANT! During a run, do not open the instrument door, and avoid touching the instrument. Touching the instrument during the sequencing run can reduce the quality of the measurements.

When the sequencing run is complete, the instrument automatically performs the cleaning procedure unless the **Enable post-run clean** checkbox was deselected. After cleaning, the touchscreen returns to the main menu.

IMPORTANT! Do NOT reuse the Ion S5[™] Sequencing Reagents cartridge after a post-run clean. The cartridge is unusable and should be discarded appropriately.




Supplemental procedures

Perform a manual cleaning of the sequencer

A cleaning protocol is normally performed automatically at the completion of each sequencing run. If a cleaning is necessary, perform the following procedure.

- On the home screen, select Settings > Clean Instrument.
 The instrument door unlocks allowing access to the consumables.
- **2.** Remove the Precision ID Wash Solution bottle to access the waste reservoir, then remove and empty the waste reservoir.



- 3. Reinstall the empty waste reservoir and a *used* Precision ID Wash Solution bottle.
- **4.** Ensure that the Ion S5[™] Precision ID Sequencing Reagents cartridge and Precision ID Wash Solution bottle are properly installed.

IMPORTANT! Perform the cleaning with a used reagent cartridge and wash solution bottle installed. The cleaning procedure pumps cleaning solution into the wash solution bottle and reagent cartridge making them unsuitable for sequencing.

- **5.** Place a used sequencing chip in the chip clamp, then push the chip clamp in all the way to engage.
- **6.** Close the instrument door, then tap **Next**. Cleaning takes ~35 minutes to complete. On completion the instrument door automatically unlocks and the chip and cartridge clamps disengage.
- 7. Proceed to "Initialize the sequencer" on page 80.

Perform an instrument reset run with an initialized, unused Ion S5[™] Precision ID Sequencing Reagents cartridge

Cleaning is normally automatically performed at completion of a sequencing run. If an Ion $S5^{\text{\tiny{TM}}}$ Sequencer is initialized and

- a sequencing run is not started within 24 hours after initialization, or
- a sequencing run is not completed due to a power failure or an abort, and <200 flows occurred before the stoppage,

then an instrument reset run is required to ensure proper cleaning before reinitialization. Do NOT perform a manual cleaning with an unused, initialized Ion S5[™] Precision ID Sequencing Reagents cartridge.

Note:

- If a power failure or abort occurs during the second of two runs started after a single initialization, a manual cleaning is sufficient (see page 102).
- If the number of flows that occurred before a power failure or abort is unknown, perform an instrument reset run.

To perform an instrument reset run, use the following procedure before reinitialization.

- In the instrument touchscreen main menu, tap Run.
 The instrument door unlocks and the chip clamp disengages.

- In the Select Run screen, tap Edit, then in the Detail screen set the number of flows to 200. Ensure that the Post-Run/Clean checkbox is selected, then tap Close.
- **6.** Tap **Start run**, then tap **Accept** to confirm that Post-Run Clean is enabled, and to start the run.

When the instrument reset run completes, the instrument automatically performs the cleaning procedure. After cleaning, the touchscreen returns to the main menu.



Glossary

Aligned read length

The aligned length of a read at a given accuracy threshold is defined as the greatest position in the read at which the accuracy in the bases up to and including the position meets the accuracy threshold. For example the AQ17 length of a read is the greatest length at which the read error rate is 2% or less. The "perfect" length is simply the longest perfectly aligned segment. For all of these calculations the alignment is constrained to start from position 1 in the read - in other words, no 5' clipping is permitted.

Aligned reads

The number of bases covered by reads aligned to the reference sequence.

AQ Score / Alignment Quality Score An AQ score defines read accuracy when compared to the reference sequence. The discrepancy can be biological (real variant) or technical (sequencing error). For example, an AQ score of 17 represents 2% aligned read error rate, while an AQ score of 20 represents 1% aligned read error rate when compared to the reference sequence.

Average base read depth

The average number of reads of all targeted reference bases that were read at least once.

Average base coverage depth

The average number of reads of all targeted reference bases.

BAM file

Binary Aligned/Mapped file—BAM file—contains aligned reads sorted by reference location. BAM file is the binary form of the SAM (Sequence Alignment/Map) file.

Barcode

There are several applications for barcodes. Libraries can be molecularly barcoded with unique nucleic acid sequence identifiers. Library barcodes are used during data analysis to sort the sequencing results from sequencing reactions that contain combined libraries. Chips and sample tubes also contain unique numeric barcodes that aid in the setup of the experimental workflow.

Bead loading

The percentage of chip wells that contain live ISPs. The percentage value considers only potentially addressable wells. Bead loading is calculated as No. of Loaded ISPs ÷ No. of potentially addressable wells.

BED file

Browser Extensible Data file—BED file—defines chromosome positions or regions.

Clonal ISP

An ISP is clonal if all of its DNA fragments are cloned from a single original template. All fragments on such a bead are identical and respond in unison during a nucleotide

flow across the chip.

Empty wells

Wells on a chip that do not contain an ISP.

Final library reads Number (and percentage) of reads, passing all filters that are recorded in the

unmapped BAM file. This value may be different from the Total number of reads located in the Library Summary Section due to specifications associated with read trimming beyond a minimal requirement resulting in total number of reads being

slightly less than Final Library Reads.

Flow A flow is the event of exposing the chip to one particular dNTP, followed by a

washing step.

Flow order

The order in which the chip is exposed to each particular dNTP. The default Samba

flow order consists of a 32-base sequence, repeated. This flow order resists phase errors by providing opportunities for out-of phase molecules to catch up and is designed to sample all dimer (nucleotide pair) sequences efficiently. Samba is the default flow order because it improves sequencing accuracy for longer reads by

resisting phase errors.

Hotspot Regions

file

A BED or a VCF file that defines regions in the gene that typically contain variants and enables Torrent Variant Caller to identify if a specific variant is present or absent. A Hotspot Regions file instructs the Torrent Variant Caller to include these positions in its output files, including evidence for a variant and the filtering thresholds that disqualified a variant candidate. A Hotspot Regions file affects only the variantCaller plugin, not other parts of the analysis pipeline. If you don't specify a Hotspot Regions file, the software will only tell you the difference between your sequence and the

reference genome.

ISPs Ion Sphere[™] Particles (ISPs) are particles that contain bound copies of a single

(ideally) DNA fragment amplified during template preparation.

Key signal Average 1-mer signal in the library key.

Library ISPs Live ISPs that have a key signal identical to the library key signal.

Library Key A short known sequence of bases used to distinguish a library fragment from

a test fragment (for example: "TCAG").

Live ISP ISP with a signal of sufficient strength and composition to be associated with the

library or Test Fragment key.

Mapped reads Sequencing reads that have been mapped to the reference sequence.

Mean raw

accuracy

Average raw accuracy of 1-mers at a specific position in the read.

MNP Multiple Nucleotide Polymorphism (MNP) is a genetic mutation in an allele that

differs from the reference allele of the same length by >1 nucleotide.

On target reads Sequencing reads mapped to any target region of the reference. A read is considered

to be on target if at least one aligned base overlaps a target region. A read that overlaps a targeted region but where only flanking sequence is aligned, for example,

due to poor matching of 5' bases of the read, is not counted.

Output files Output files consist of all BAM files, run reports, and plugin results.

Planned Run A file that contains all the specifications, setting, and parameters for template

preparation and chip loading on the Ion Chef[™] Instrument, and sequencing on an Ion

S5[™]/Ion S5[™] XL or Ion GeneStudio[™] S5 Series System.

Planned Run template

A reusable experimental design (digital protocol) for the sequencing instrument that holds specifications for sample preparation, sequencing, data export, and post-

sequencing data analysis.

Polyclonal ISP An ISP that carries clones from two or more library sequences.

Primer dimer ISP An ISP that carries an insert length of less than 8 base pairs.

Q Score Phred Quality score - Q Score - is used to measure the accuracy of the nucleotide

sequence generated by the sequencing instrument. The Q Score represents the

probability that a given base is called incorrectly by the sequencer.

Q17 Predicted error rate of 2%.

Q17 bases The number of bases that have a Q Score of ≥17 in a given sequencing output.

Q20 Predicted error rate of 1%.

Q20 bases The number of bases that have a Q Score of ≥20 in a given sequencing output.

Read The sequence of a section of a unique fragment obtained after the end of the

sequencing process.

Read length The length of called reads measured in base pairs.

Reference library A consensus nucleotide sequence that represents the genome of a particular species.

The results from a sequencing run are compared to the reference library to identify

sequence variants.

Relationship group Defines related samples within a Sample Set. Related samples are designated by the

same relationship group number.

SAM file Sequence Alignment Map (SAM) is a text-based output file that stores biological

sequences aligned to a reference sequence.

Sample Genetic material from one source (for example: DNA from one individual).

Signal Processing Input files

Signal Processing Input files consist of the raw voltage measurement data collected during the sequencing run. These files are required to re-analyze the run from Signal

Processing.

SNP Single Nucleotide Polymorphism (SNP) is a genetic mutation in an allele that differs

from the reference allele of the same length by one nucleotide.

STR Short Tandem Repeat (STR) is a repeated genomic sequence, variations in which are

useful in human identification.

System SNR System Signal-to-Noise Ratio.

System template A Planned Run template that comes pre-loaded on the Torrent Suite™ Software.

System templates are designed to facilitate the user in creating a Planned Run or a customized Planned Run template for a specific research application. System

templates cannot be deleted from the Torrent Server.

Target base coverage

Summary statistics for targeted base reads of the reference. A base covered by

multiple target regions is only counted once per sequencing read.

Target Regions file A BED file that specifies all the regions that a panel represents such as the amplified

regions that are used with target sequencing. The complete Torrent Suite $^{\text{\tiny TM}}$ Software analysis pipeline, including plugins, is restricted to only these specified regions

instead of analyzing the entire reference library.

Test Fragment (TF) Known nucleotide sequence that is used to monitor system characteristics.

Test Fragment ISPs

Live ISPs with a key signal that is identical to the Test Fragment Key signal.

Test Fragment Key (TF Key)

The nucleotide sequence that is used to identify test fragment reads.

counts

Signal strength of the first three bases of the TF Key.
